## UN Convention on the Rights of Persons with Disabilities\*

Article 1 – Purpose

"The purpose of the present Convention is to promote, protect and ensure the full and equal enjoyment of all human rights and fundamental freedoms by all persons with disabilities, and to promote respect for their inherent dignity.

Persons with disabilities include those who have long-term physical, mental, intellectual or sensory impairments, which in interaction with various barriers may hinder their full and effective participation in society on an equal basis with others.

# Scheme of Providing Incentives to Employers in the Private Sector for Providing Employment to Persons with Disabilities.

#### I. Introduction

- 1. As per Census, 2001, there are 2.19 Crore Indians with disability visual, hearing, locomotor and mental.
- 2. The Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, mandates 3% reservation in suitably identified posts in Government establishments for persons with disability. This provision is being implemented by Central and all State Governments, including PSUs and Autonomous Bodies fully funded by the Government.
- 3. There are numerous examples of persons with disability being gainfully employed including in the higher echelons;
  - ➤ Blind persons are practicing as High Court Lawyer, Chartered Accountant, etc. A premier software company has employed a blind person as Risk Analyst.
  - ➤ A number of blind persons perform BPO and other jobs using talking software (JAWS).
  - ➤ Persons with hearing impairment perform various jobs in assembly units.
  - Many persons with Mental Retardation have been working efficiently in printing industry doing various jobs like cutting of paper, etc.
  - Large number of persons with locomotor disability successfully do a wide variety of jobs.
  - ➤ Persons with disability are also now being recruited into All India Services and Group 'A' posts in Central Services.

4. Persons with disabilities have thus proved themselves to be productive members of the workforce in various employments.

In many cases, they have proved themselves to be better employees than those without disabilities.

What is needed is to give them an opportunity for employment so that they are able to lead a life of dignity and economic independence.

- 5. Government has been supporting Vocational training of persons with disabilities
  - 20 Vocational Rehabilitation Centres are being run by the Ministry of Labour & Employment in 17 States and 2 UTs to assess the capacity of persons with disabilities and train them accordingly so that they may take up suitable vocations. One of the VRCs (in Vadodara) is exclusively for women with disabilities. The 20 VRCs rehabilitated about 11,200 persons with disability during 2006
  - About 200 NGOs are supported by the Ministry of Social Justice & Employment for providing vocational training to persons with disabilities
  - There are also 43 **Special Employment Exchanges** catering exclusively to persons with disability as also 38 **Special Cells** for them, under a Special Placement Officers attached to a normal **Employment Exchange.**
  - 6. **Paralympics** are organized as the equivalent of the Olympics for persons with disabilities.

Likewise, **Abilympics** are organized at state, national and international levels to showcase vocational abilities of persons with disabilities. The Ministry of Social Justice & Empowerment supports Abilympics at all three levels of competition.

7. National Awards are given by the Central Government every year for the best employer, who hires persons with disabilities. These awards are given on the International day of Disabled Persons (3rd December)

## II The Union Finance Minister's, Budget Speech of 2007- 08 had stated inter alia as follows:

#### Employment for the Physically Challenged

105. Among the disadvantaged sections of the society are physically challenged persons. They face difficulties in obtaining regular employment. In order to incentivise employers in the organized sector to provide regular employment, I purpose a scheme whereunder Government will reward the employer once the physically challenged employee is regularized and is enrolled under the Employees Provident Fund (EPF) and the Employees State Insurance (ESI). Under the scheme, Government will reimburse the employer's contribution to the EPF and ESI for the first three years..."

#### **III** The Scheme:

In pursuance of the above, Government of India has introduced a new scheme with effect from 1.04.08 with the following salient features:

#### **Nature of Incentive to Employers:**

Payment by the Central Government of the employer's EPF and ESI contribution for the first three years, for each person with disability employed in a private sector establishment. (The administrative charges of 1.1% of the wages under EPF will however have to be paid by the employer).

#### The Incentive is available for Employees with Disabilities:

- ➤ Appointed on or after 1.4.2008 in a private sector establishment
- ➤ On a monthly wage up to Rs.25, 000/-
- ➤ Having a Disability Certificate issued by a Competent Medial Board under the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995.
  - "Disability" under the above Act includes:
    - o blindness,
    - o low vision,
    - o leprosy-cured,
    - o hearing impairment,
    - o locomotor disability (including Cerebral Palsy)
    - o mental retardation
    - o mental illness
- The Act defines a "**person with disability**" as one "suffering from not less than 40% of any disability as certified by a Medical Authority"

### IV Two simple steps to be taken by the Employer for availing the incentive are:

- Appoint a person with disability
- Inform the concerned EPFO / ESIC office, in the prescribed proforma, with a valid Disability Certificate of the employee.
